SUBJECT:	Grant Funding Process
OBJECTIVE:	Information

Issue

Considering recent federal legislation directed toward renewal of the nation's infrastructure, staff observed an opportunity to formalize a standardized grant funding process enhancing EWEB's strategic positioning to leverage funding opportunities and prioritize grants in capital and project planning.

Background

Prior to 2020, large grant awards were provided through the Federal Emergency Management Agency's (FEMA) Public Assistance program and were a function of disaster recovery efforts, typically following winter storms. Since 2020, EWEB has received over \$20 million in grant awards from six federal and state sources for a range of projects. With recent emphasis on recovery from the 2020 wildfires, EWEB is now adapting to focus on grant funding for infrastructure and resiliency projects.

Discussion

Foundations and Successes

2021 was a transformative period with the inception of the Grants Specialist role and the establishment of the Grants Working Group. This cross-functional team was an intake hub for grant opportunities and supported grant logistics, such as compliance and accounting. Complementing this, the Grants Oversight Committee, composed of Executive Team members, Finance Management, and the Grants Specialist, convened monthly to provide strategic direction.

Since the September 2020 wildfires, EWEB has directed most grant resources to recovery and source water protection efforts. Funding for damage done to EWEB's infrastructure during the 2020 wildfires and other resiliency/hardening projects came from FEMA, while significant work upriver has been successfully completed through grant funding from a variety of sources. Attachment 2 includes a listing of grant awards received by EWEB since 2020. In addition, collaborative efforts with partner agencies generated awards from the National Oceanic and Atmospheric Administration and Department of Energy's Grid Resilience Innovation Program totaling \$9.5 million.

Since December 2022, EWEB has participated in several opportunities to provide feedback on a grant funding announcement issued by Oregon Department of Energy and advocating for inclusion of community energy resilience funding along with ways to maximize community impact through equity. State funding allocations for federal grant programs represent an important way for EWEB to access federal funds, particularly because EWEB will be more competitive at the state level and these grants contain fewer barriers to access.

EWEB also engaged a consultant to assist in developing a comprehensive funding strategy looking at both competitive and noncompetitive funding opportunities to align with EWEB's near and long-term goals. They assist EWEB with identifying and prioritizing federal funding opportunities.

Future Opportunities

With significant awards for wildfire recovery and mitigation work, Staff have shifted focus to new opportunities leveraging alternative funding available through the Infrastructure Investment & Jobs Act (IIJA), Inflation Reduction Act (IRA), Oregon Department of Energy (ODOE), and other federal or state opportunities included in Attachment 1.

EWEB's organization goal to access alternative funding opportunities includes an internal exploration, evaluation, and review process in 2024. Leveraging the grants framework already established over the last several years, Staff will establish a structured framework for sourcing grants. The goal is to more effectively make resource-focused decisions and enhance competitiveness, doing so with a commitment to a foundation reflecting our community values and meeting federal requirements, like Justice40, as well as incorporating principles of diversity, equity, and inclusion, and workforce development.

A part of this approach includes a focus on two tracks for grant funding:

- Alternative funding for established priorities Staff will align funding opportunities with the existing Capital Improvement Plan, Water Master Plan, division goals, Wildfire Mitigation Plan, Natural Hazards Mitigation Plan, and the Community Wildfire Protection Plan, among others. Timing considerations will necessitate project prioritization based on funding opportunities.
- 2. Opportunistic grants to fund strategic objectives Over the coming year, Staff will identify, scope, and understand these projects, prioritizing based on business continuity, resiliency, and resource optimization.

The first half of 2024 initiates the formalization process with key focuses, including:

- Renewal of the Grants Oversight Committee as the body providing high-level decisionmaking, ensuring alignment with organizational goals and evolving needs, as well as strategic configuration of the grants program to allocate required resources.
- Reformation of the Grants Working Group with broad cross-divisional representation, fostering brainstorming and insights into capital and master plans and support to identify and scope potential projects with strategic objectives as noted within Track 2.
- Establish industry-wide relationships with similar sized utilities, networking support and information-sharing through quarterly meetings.
- Establish local partnerships, beginning with the Lane Regional Climate Collaborative, a task force comprised of local government and public entities in the Eugene/Springfield community dedicated to collaboration and information sharing in attracting grant dollars to our community.
- Develop a formal positioning strategy for grant identification based on resources, competitiveness, and relevance. Focusing on opportunities aligned with our criteria ensures a targeted approach, optimizing existing resources.

Attachment 1 – Recent Submissions

- Submitted a \$5 million request for Federal Department of Energy's (DOE) Maintaining and Enhancing Hydroelectricity Incentives program to provide three years of funding for dam safety and infrastructure improvements for ESA listed species at the Smith Spillway.
- Submitted an application for DOE's Regional/Municipal Utilities Cybersecurity Prize which can award up to \$200,000 and Technical Assistance for support to successful applicants.
- Following an unsuccessful application in 2022, EWEB submitted a more refined request for \$6.9 million in funding from US Department of Agriculture's Community Wildfire Defense Grant for fuels treatment upriver, in Eugene's Wildland Urban Interface areas, and around EWEB's future second source.
- Partnered with Portland General Electric and Clark Public Utility District on a concept paper for the second round of DOE's Grid Resilience and Innovation Partnerships (GRIP) grant to fund a regional effort towards advanced distribution management systems.
- Submitted an application for a State Preparedness and Incidence Response Equipment grant. If successful, EWEB will receive a 900-gallon mobile water tanker.

OBJECTIVE:	Information

Issue

EWEB monitors, influences, and strategically plans around legislative and regional policy issues.

Background

The Board adopts general policy directives for advocacy on legislation and other public policy matters, which guide the work of EWEB's lobbying activities. When political considerations test the applicability of those directives, the General Manager makes a determination as to whether a fundamental shift in direction is required. The Board may be asked to reaffirm policy directives or direct staff to make necessary adjustments.

Discussion

The following is an update on interim state and federal legislative/administrative issues.

Emerging 2024 State Legislative Session Issues:

Since the EWEB Board adopted the utility's 2024 State Legislative Agenda a new issue of interest to EWEB has emerged, although it will not be confirmed that this topic will be addressed until the release of 2024 session bills on January 31st.

Recreational Immunity

In 2023 an Oregon appellate court decision called into question the tort immunity enjoyed by public and private landowners when they allow access to land free of charge for recreation. The issue in question in the case was whether a person hiking on a trail while walking their dog and socializing with a friend was recreating on the trail or was using it for transit to and from a beach recreational area. Public agencies and recreational user groups have made requests to the Legislature for a fix to ensure continued public access to recreation areas in the wake of this court decision.

There are news reports of subsequent recreational access impacts in some locales around Oregon. The legislature has a history of supporting recreational immunity and has previously amended Oregon law to provide remedy when past court decisions have put recreational access at risk.

EWEB will be monitoring for potential legislation on this topic that would clarify and relieve landowners of

unnecessary exposure to liability and litigation costs when making land accessible for recreation free of charge. If and when introduced, this bill could be beneficial to the utility and our community and could be a bill EWEB would support.

Recommendation/Requested Board Action
