Clean, accessible transportation is changing how Eugene moves

More and more people are choosing electric mobility options over gas-powered vehicles to reduce pollution, save money on fuel and maintenance, meet personal sustainability goals and help Oregon meet our climate goals.

We understand that while many people are choosing to purchase electric vehicles, they aren't accessible to everyone. With help from the Oregon Clean Fuels Program, EWEB is bridging the gap between availability and accessibility through our EV car share program, community grants and electric bike rebate.

▶ RIDE INTO SUMMER WITH A \$300 ELECTRIC BIKE REBATE

EWEB's \$300 electric bicycle (e-bike) rebate is perfect for those who want to travel faster or need a little extra assistance than a standard bike can offer.

In addition to helping you save money on transportation costs, e-bikes reduce air pollution, relieve traffic congestion and promote physical and mental health benefits.



If you have a Class 1 or Class 2 e-bike, you can take advantage of the miles of bike paths and bike lanes we have throughout the city and surrounding areas. Remember, if you are on a Class 3 e-bike you'll need to use the regular lane of traffic.

SHARE AN EV

Through our partnership with Forth Mobility, we are excited to offer the GoForth Electric Car Share program. In Eugene, we have three electric car sharing stations:

- St. Vincent de Paul Iris Place
- Lane Transit District Santa Clara Station
- City of Eugene Broadway South

The GoForth CarShare program is state wide and a great opportunity to try an electric vehicle; use it to run errands around town, or even take a day trip out of town.

COMMUNITY GRANTS SUPPORT E-MOBILITY

EWEB grants five \$25,000 electric mobility community grants each year to non-profits, educational institutions or public organizations that are working to bring electric mobility to the Eugene community.
